Having a plan in place for this is very important.Section 1 Termination of OperationsIf the Officers vote that the Club should be dissolved the motion for dissolution must receive more than two thirds vote of a full membership to pass. Section 2 Disposition of AssetsThe Officers shall handle the disbursement of all assets of the club. No member or group of members shall receive benefit from the assets. All equipment will be sold and net proceeds donated to a non-profit organization. All remaining cash will be donated to a non-profit organization.
